- Independently manage referrals from school and other professionals for eligible young people; complete assessments; create action plans; carry out home visits where needed
- Work with children and families in a supportive, holistic way to address practical and psychological barriers, coping strategies for daily living, low confidence and social isolation; work together to co-produce solutions and coping strategies
- Support communication with young people, their families and between services; advocate for young people
- Make referrals to local community groups and other services; facilitate the sharing of information and resources
- Develop relationships with schools including delivery of assemblies, groupbased support, workshops and presentations within the school environment to raise awareness of the service and deliver key messages; attend events and meetings
- Deliver one-to-one support; develop wellbeing toolkits
- Support the planning and delivery of activity days, including supporting other IMAGO projects to meet the needs of the service

- Promotion of positive mental health and prevention of mental health issues in childhood and adolescence
- Ensure achievement of performance monitoring outcomes
- Maintain excellent records; undertake regular evaluation of the service
- Work with an understanding of issues relating to lone working, safeguarding, data protection and confidentiality; and adhere to Imago policies and procedures
- Keep up-to-date with issues affecting young people, both locally and nationally
- Undertake relevant internal and external training
- Have a commitment to equal opportunities, ensuring services are accessible to all sections of the community; work with an understanding of cultural differences
